1. General Terms and Conditions

- 1.1 Any reference to "Applicant" in these Terms and Conditions shall include such person authorised to give instructions and the Joint Applicant (if any) are binding on the Applicant or as the case may be, the Joint Applicant.
- 1.2 The Applicant shall be bound by the terms in the prospectus, supplementaries (if any), product highlights sheet (collectively known as "Funds Documents"), and these Terms and Conditions with respects to all transactions.

5. Instructions/Video Recordings
